INTER-FAITH FOOD SHUTTLE'S FOOD RECOVERY AND DISTRIBUTION DIVISION ADDRESSES FOOD INSECURITY AND FOOD WASTE BY COLLECTING PERISHABLE AND SHELF-STABLE FOOD FROM DONORS. DISTRIBUTION OCCURRED THROUGH A VARIETY OF METHODS AND VENUES, INCLUDING 48 COMMUNITY PARTNERS, 83 BACKPACK BUDDIES SCHOOL SITES, 13 MOBILE MARKET LOCATIONS, 10 SCHOOL PANTRIES, AND 25 GROCERY BAGS FOR SENIORS SITES ACCROSS A 7-COUNTY SERVICE AREA. FISCAL YEAR 2020-2021 SAW A CONTINUATION OF INCREASED BULK PURCHASING CAUSED BY COVID-19 SUPPLY CHAIN DELAYS. THE FOOD SHUTTLE DISTRIBUTED 8,944,277 POUNDS OF FOOD THROUGH THE YEAR, 26% OF WHICH WAS FRESH PRODUCE.
